SLOVAKIA 2026

Security Measures

1. Team captains must be familiar with the measures and subsequently inform team members. By signing, they confirm being informed about the measures.

Rules for escort vehicles:

- 1. The runner must run on the left side of the road, it is forbidden to run on the right side in front of the vehicle.
- 2. During the daytime stage, it is forbidden to accompany the runner by any means of transport.
- 3. At night, it is allowed to accompany the runner behind him for lighting the route.
- 4. Teams can use a maximum of 2 escort vehicles, which must be marked with a sticker on the front hood.
- 5. All escort vehicles must comply with parking spots designated by the THE RUN APP and the instructions of security managers and organizers.
- 6. At parking lots with smaller capacities, competitors move only in one escort vehicle.
- 8. Traffic regulation at parking lots is ensured by the security service. The competitor moves from the parking place to the transfer place.

Interruption of the event:

1. In case of adverse weather conditions or extraordinary circumstances, the organizer may interrupt the event. Runners will move to the transfer place and wait for instructions on the continuation of the event.

Safety elements of participants:

1. The organizer will check the lighting and safety features of the runner before the transfer: functional mobile, reflective vest, headlamp, blinker, additional reflective element.

Health care:

- 1. The organizer and the health care coordinator will check the condition of the teams and provide medical assistance.

Other safety measures:

- 1. Excessive consumption of alcohol is prohibited.
- 2. Observing quiet hours from 10 PM to 6 AM.
- 3. Information will be provided through the mobile network and contacts of responsible persons.

Sanctions for rule violations:

1. Non-compliance with security service instructions is addressed with sanctions: First warning: + 30 min, Second warning: + 60 min, Third warning: team disqualification.
